RESOLUTION NO. 13-TM-23

**BE IT RESOLVED BY THE TRIBAL COUNCIL OF THE TE-MOAK TRIBE OF WESTERN SHOSHONE INDIANS OF NEVADA, THAT**

**WHEREAS**, this organization is an Indian Organization as defined under the Indian Reorganization Act of June 18, 1934, as amended, to exercise certain rights of home rule and to be responsible for the promotion of economic and social welfare of its Tribal members, and

**WHEREAS**, the Te-Moak Tribe of Western Shoshone Tribal Council is composed of Constituent Bands known as the Battle Mountain Band Council, Elko Band Council, South Fork Band Council and Wells Band Council; and

**WHEREAS**, the Te-Moak Tribe of Western Shoshone is to provide decent, safe and sanitary housing for all tribal members in need of housing assistance; and

**WHEREAS**, the Te-Moak Tribe of Western Shoshone Council have motioned by majority vote **Resolution 13-TM-23** dissolving the current Te-Moak Tribe of Western Shoshone Tribal Council as the current Te-Moak Tribally Designated Housing Entity (TDHE) to be effective on August 15, 2013.

**NOW THEREFORE BE IT RESOLVED**, the Te-Moak Tribe of Western Shoshone Tribal Council selects the following individuals to serve as the Te-Moak Housing Authority Board of Commissioners to serve in the term of office in staggered terms according the Housing Ordinance Article IV, Sec 4,(b).

**FUTHER BE IT RESOLVED**, The Tribal Council selected the following individuals, Paula Brady, Christine Oppenheim, Raymond Gonzales Sr., Doyle Tybo, Steve Brady, Gilbert Temoke, and Rhonda Hicks as the Te-Moak Housing Authority Commissioners.

**FINALLY BE IT RESOLVED**, According to the Housing Ordinance, Article IV, Sec. 4, (c) The Council has named Raymond Gonzales Sr. by majority vote to serve as the chairman for a 4 year period, and this resolution hereby rescinds any and all prior resolutions dissolving the present TDHE.

I, the undersigned as the Chairman of the Te-Moak Tribal Council of the Te-Moak Tribe of Western Shoshone Indians of Nevada, do hereby certify that the council is composed of **9** members of whom **6** constituting a quorum were present at a duly held meeting on the **18<sup>th</sup> day of July 2013**, that the foregoing Resolution was adopted by a vote of **6-FOR 0-AGAINST 0-ABSTENTIONS**, pursuant to power vested with the Tribal Council in Article 4, Section 3 (k) and (m) of the Constitution of the Te-Moak Tribe of Western Shoshone Indians of Nevada.
