## RESOLUTION OF THE GOVERNING BODY OF THE TE-MOAK TRIBE OF WESTERN SHOSHONE INDIANS OF NEVADA

### RESOLUTION NO. 14-TM-29

**BE IT RESOLVED BY THE TRIBAL COUNCIL OF THE TE-MOAK TRIBE OF WESTERN SHOSHONE INDIANS OF NEVADA, THAT**

**WHEREAS**, this organization is an Indian Organization as defined under the Indian Reorganization Act of June 18, 1934, as amended, to exercise certain rights of home rule and to be responsible for the promotion of economic and social welfare of its Tribal members, and

**WHEREAS**, the Te-Moak Tribe of Western Shoshone Tribal Council is composed of Constituent Bands known as the Battle Mountain Band Council, Elko Band Council, South Fork Band Council and Wells Band Council; and

**WHEREAS**, the Te-Moak Tribe of Western Shoshone is to provide decent, safe and sanitary housing for all tribal members in need of housing assistance; and

**WHEREAS**, the Te-Moak Tribe of Western Shoshone Council have motioned by majority vote by **Resolution 13-TM-23** dissolving the current Te-Moak Tribe of Western Shoshone Tribal Council as the Te-Moak Tribally Designated Housing Entity (TDHE) to be effective on August 15, 2013; and

**WHEREAS**, the Te-Moak Tribe of Western Shoshone Tribal Council has selected and appointed the following individuals to serve as the Te-Moak Housing Authority Board of Commissioners according the Housing Ordinance Article IV, Sec 4,(b).

**WHEREAS**, The Tribal Council selected the following individuals, Paula Brady, Christine Oppenheim, Raymond Gonzales Sr., Doyle Tybo, Steve Brady, Gilbert Temoke, and Rhonda Hicks as the Te-Moak Housing Authority Commissioners; and

**WHEREAS**, the Te-Moak Housing Authority Commissioners has approved by Resolution No. 14-TMHA-13 on March 20, 2014 with the staggered terms as follows:

Christine Oppenheim, Member	1-year term
Paula Brady, Member	2-year term
Doyle Tybo, Member	2-year term
Steve Brady, Member	3-year term
Rhonda Hicks, Secretary	3-year term
Gilbert Temoke, Vice-Chairman	4-year term
Raymond Gonzales, Sr., Chairman	4-year term

**WHEREAS**, Christine Oppenheim, 1-year term ended on August 15, 2014, and the Te-Moak Housing Authority Board of Commissioners has requested formally through a letter dated July 22, 2014, that Ms. Oppenheim be reappointed as a TMHA-BOC member.


